## RE: Notice of Intent to File Citizen Enforcement Claim Pursuant to Clean Air and Act § 304(b)(2), 42 U.S.C. § 7604(b)(2)

Dear Administrator McCarthy:

This letter provides notice under Clean Air Act § 304(b)(2), 42 U.S.C § 7604, and 40 C.F.R. § 54.3(a) that Concerned Citizens Around Murphy ("Concerned Citizens") intend to file a citizen-suit claim against EPA under 42 U.S.C. § 7604(a)(2) for failure to grant or deny the Concerned Citizens' April 3, 2012 Title V Petition ("the Petition"). The Concerned Citizens hope they can reach a negotiated resolution of this issue with EPA, but submit notice at this time to preserve their rights under § 304.

On September 21, 2011, EPA sent an Order to the Louisiana Department of Environmental Quality ("LDEQ") objecting to Title V permit No. 2500-00001-V5 (the Permit) for a refinery in Meraux, Louisiana that Valero Refining-Meraux, LLC now owns. LDEQ responded to EPA's September 21, 2011 Objection on December 20, 2011 ("LDEQ's Response"). The Concerned Citizens are informed and believe that EPA is treating LDEQ's Response as an amendment to the Permit. On April 3, 2012, the Concerned Citizens filed the Petition with EPA, pursuant to Clean Air Act § 505(b)(2), 42 U.S.C. § 7661d(b)(2), requesting that EPA object to the Permit because, *inter alia*, LDEQ's Response did not resolve EPA's September 21, 2011 Objection and the Permit is not in compliance with the Clean Air Act's requirements. The Concerned Citizens timely filed the Petition, "within 60 days after the expiration of [EPA's] 45-day review period" under 42 U.S.C. § 7661d(b)(2). Under the Act, "[t]he Administrator shall grant or deny such petition within 60 days after the petition is filed." 42 U.S.C. § 7661d(b)(2). Because the Concerned Citizens filed its Petition on April 3, 2012, the Act required EPA to grant or deny the Petition by at least June 3, 2012. EPA failed to do so and has still not granted or denied the Petition.

> EPA's failure to grant or deny the Petition within the 60-day period required by 42 U.S.C. § 7661d(b)(2) is a failure to perform a non-discretionary act, which is actionable under the Clean Air Act citizen suit provision. 42 U.S.C. § 7604(a)(2) ("any person may commence a civil action on his own behalf ... (2) against the Administrator where there is alleged a failure of the Administrator to perform any act or duty under this chapter which is not discretionary"). The Concerned Citizens may file a claim in the U.S. District Court for the Eastern District of Louisiana 60 days from the postmark date on this notice letter to enforce EPA's duty to respond to the Petition. *See* 40 C.F.R. § 54.2(d) ("Notice served in accordance with the provisions of this part shall be deemed given on the postmark date, if served by mail.").

> Due to EPA's failure to perform its non-discretionary duty to respond to the Petition within 60 days, the Concerned Citizens gives notice that, in the event a timely negotiated resolution is not practical, it intends to file a citizen suit claim (probably by amending its current lawsuit) to require EPA to perform this duty.
