Re: Sixty-Day Notice of Intent to Sue for Violations of the Clean Water Act - Failure to Require NPDES Permit for the Interim Response System at the Buck Mine Discharge Site.

This letter serves as a sixty-day notice by Richard Sloat of my intent to sue the United States Environmental Protection Agency ("EPA") for violations of the than Water Act 33 U.S.C. §1251 et seq. (1972) as a direct result of EPA's failure to require a National Pollutant Discharge Elimination System (NPDES) permit for industrial discharges (waste mine water) from for the Interim Response System for the Buck Mine Discharge Site. This site is located in the NE 1/4 – SE ¼ and the SE ¼ - SE ¼ of Section 1, T42N - R35W, City of Caspian, Iron County, Michigan.

This notice is pursuant to Section 505(a)(2) of the Clean Water Act (CWA) to notify EPA that unless it corrects this violation prior to such time as these industrial discharges reach the Iron River but no sooner than 60-days from receipt of this notice, I will seek redress in federal court. 33 U.S.C. § 1365(a)(2); 40 C.F.R. § 135.

Though administration of the Clean Water Act has been delegated to the state of Michigan, the EPA remains ultimately responsible for compliance with federal laws it is charged with enforcing, including the Clean Water Act. EPA has a duty to consult with states which have delegated authority and to require states to enforce the laws. EPA does not have the authority to allow states to do anything less. That is, however, exactly what has happened in this instance.

I. IDENTIFICATION OF THE PARTIES

Richard Sloat is a resident of Iron County, Michigan. Richard Sloat has repeatedly raised questions and referenced the Buck Mine Interim Response System at several public hearings that the Michigan Department of Environment Quality (DEQ) has been in attendence. Richard Sloat has also requested under the Freedom of Information Act if the DEQ has a National Pollutant Discharge Elimination System (NPDES) permit and received this response:

No records were found in the WRD per the description of documents on your attached FOIA request.
