Re: Notice of Intent to File Suit, Failure to Act on Clean Air Act State Implementation Plan Submissions from Region 8 States

Dear Administrator Jackson:

This letter is to inform you that WildEarth Guardians intends to filed suit against the U.S. Environmental Protection Agency ("EPA") over the agency's failure to take action on several Clean Air Act State Implementation Plan ("SIP") submissions from the States of Colorado, South Dakota, and Utah, as required by Section 110(k)(2) of the Clean Air Act. 42 U.S.C. § 7410(k)(2). We intend to bring a suit 60 days from the date of this letter, or shortly thereafter, under Section 304 of the Clean Air Act, 42 U.S.C. § 7604, against you for your failure to perform a nondiscretionary duty set forth in 42 U.S.C. § 7410(k)(2).

The SIP submissions at issue, which were provided to WildEarth Guardians by EPA Region 8 in a list, include the following:

Under the Clean Air Act, states are required to submit SIPs to the EPA to implement, maintain, and enforce the NAAQS. *See* 42 U.S.C. § 7410(a). The Clean Air Act further requires the Administrator to fully or partially approve or disapprove a SIP submission within 12 months after such submission has been deemed complete, either by the Administrator or as a matter of law. *See* 42 U.S.C. § 7410(k)(2). If the EPA does not make a completeness finding, SIP submissions are deemed complete by operation of law six months of submissions. *See* 42 U.S.C. § 7410(k)(1)(B). Therefore, at most, EPA had 18 months within which to take final action to approve, disapprove, or partially approve or disapprove the aforementioned SIPs from the States of Colorado, South Dakota, and Utah.

For the Colorado SIP submissions, EPA was required to take action by November 25, 2012. For the South Dakota SIP submissions, EPA was required to take action by December 14, 2011 and December 20, 2012. For the Utah SIP submission, EPA was required to take action by January 14, 2013. EPA has not taken action to fully or partially approve or disapprove the aforementioned SIP submissions as of the date of this letter. We therefore intend to bring suit 60 days from the date of this letter over your failure to perform a nondiscretionary duty required by the Clean Air Act, 42 U.S.C. § 7410(k)(2).

WildEarth Guardians is a New Mexico-based nonprofit organization with offices in Denver and Phoenix. WildEarth Guardians is dedicated to protecting and restoring the American West and has members who are harmed by the failure of the Administrator and the EPA to follow through with duties under the Clean Air Act to ensure that SIPs are timely acted upon to ensure adequate protection of air quality and public health and welfare.
