

UPDATE ON E-MANIFEST SYSTEM STATISTICS

- Average Daily Submission:
 - **5**,500
- Original estimate: 3.5M/year
- Current pace: 2M/year
- Paper processing backlog burndown in progress



COMMON MISTAKES WITH MAILED MANIFESTS

- 1. Many manifests that are disheveled, illegible, have multiple lines partially crossed out, missing key information.
 - Receiving Facilities Please have current phone number
- 2. Generators mailing paper manifests to EPA
- 3. Multiple generators/transporters/TSDF's not signing or dating their manifests
- 4. No Management Method Codes for Hazardous Waste
- 5. Incomplete PCB Information
 - Load type
 - Weight in KGs
 - Earliest date of Removal from Service
- 6. Sites are not registering their facilities

- Searching and requesting access to a site
- Searching for a manifest tracking number

E-MANIFEST ICR UPDATE



- Comment period closed April 9, 2019
- I1 comments were submitted by industry and state stakeholders
- Comments are under evaluation by the EPA and are publicly available at <u>www.regulations.gov</u> - EPA Docket Number: EPA-HQ-OLEM-2018-0756
- Possible form revisions will reflect commenter input

NEW E-MANIFEST RULE



- EPA is commencing work on a 3rd e-Manifest Rule.
- This rule is anticipated to address regulatory matters that were not resolved in either the 2014 One Year Rule or the 2018 User Fee Rule.
 - Integrating export manifests into the e-Manifest system, and
 - Integrating Manifest-related Reports into the e-Manifest system.
 - Exception Reports, Discrepancy Reports, and Unmanifested Waste Reports
- EPA will publish for public comment a proposed rule before finalizing regulatory changes.
