- For state/EPA: RCRAInfo Conference July 2021


Mailed Submissions per Month

 - 90% of mailed manifests for June are submitted by 3 facilities.




FY 2021 Submission Summary

Mailed Manifest Phaseout June 30, 2021

e-Manifest

 Beginning June 30, 2021 (today), EPA will no longer accept mailed paper manifests from facilities for processing in e-Manifest

 Manifest and continuation sheet submissions will only be accepted in electronic, hybrid, data plus image, and image format

 After June 30, EPA will return all manifests and continuation sheets that are mailed to the e-Manifest PPC


FY 2022/2023 User Fees

Data + Image Upload	\$13
Electronic	\$8

- Any manifest that originates (signed by the generator) on or after October 1, 2021, will be charged the fiscal years 2022 and 2023 user fee rate when submitted to the e-Manifest system by the receiving facility.
- Receiving facilities will see their first invoices reflecting the new rates starting in November 2021.
- The fee period will end September 30, 2023.

New Registered Status Report - Demo

This report is designed to help users identify which handlers have the ability to e-Sign, Quick Sign, and/or have at least one registered user for their site.




Archiving Old Manifests

- EPA is looking to start an Archival Process for Manifests whose Ship Date (date signed by the initial transporter) is greater than 3 years old.
- EPA has already heard from states and industry that the manifests must be accessible and able to be corrected.
- EPA's current thinking is archiving manifests so that they are not automatically downloaded on the EPA Dashboard, unless the site searches on them and requests that they are downloaded.
- In addition, users will still be able to search and find older manifests with reports using the custom date range function.
